System Inspectors who perform inspections pursuant to 310 CMR 15.301 shall be: (a) Massachusetts Registered Professional Engineers with a concentration in civil, sanitary or environmental engineering; Massachusetts Registered Sanitarians; or Certified Health Officers; or (b) Board of Health members or agents, Engineers in Training (EIT certified) with a concentration in civil, sanitary, or environmental engineering, professional home inspectors, licensed septage haulers or system installers, or other individuals with a minimum of one year of demonstrated experience in septic system inspection, who have attended training provided or authorized by the Department; and who have passed an examination prepared and administered by the Department or an agent authorized by the Department to qualify as an approved System Inspector pursuant to 310 CMR 15.34-(2).

Please read all questions carefully and answer fully. Application must be filled out completely, where applicable, and proof of eligibility attached.

Type or print clearly in ink only.

Attach recent photo with face not less than one inch wide, or a copy of driver's license may be used. **Please note this is a mandatory requirement.**
