## **Title 5 Renewal Fact Sheet**

Certification as an approved Title 5 System Inspector (SI) or Soil Evaluator (SE) is valid for three years. Renewal requirements for these approvals are based upon the date of initial approval. For the <u>first</u> renewal (3 years from the date of initial approval), no training contact hours (TCHs) are required. At the time of the filing of a *subsequent* (2<sup>nd</sup>, 3<sup>rd</sup>, etc.) renewal application (6 years, 9 years, etc. from the date of initial approval), proof of having obtained ten (10) approved TCHs *during the previous three years* must be provided. Please see the chart below for renewal schedule:

<u>PLEASE NOTE</u> – Those individuals who would like to maintain their Title 5 approval, *but are not active in the field* can switch to INACTIVE status. SIs and SEs with INACTIVE status are not required to obtain TCHs; however, they must still pay the \$100 renewal fee and return the completed renewal form. It is important to note that those switching to INACTIVE status <u>CANNOT</u> conduct Title 5 system inspections or soil evaluations. A SI or SE with INACTIVE status can change their status to ACTIVE (and return to conducting Title 5 system inspections or soil evaluations) by submitting evidence of having obtained 10 approved training contact hours *within the same calendar year*, completing a change of status form, and paying a \$25 administrative fee.
